

NOTICE OF LOCAL PLAN EXAMINATION HEARING SESSIONS



CHELMSFORD CITY COUNCIL

Chelmsford City Council submitted the Chelmsford Draft Local Plan to the Secretary of State for Independent Examination on 29 June 2018 in accordance with Regulation 22 of the Town and Country Planning (Local Planning) (England) Regulations 2012.

The Chelmsford Local Plan will guide growth and development across Chelmsford City Council's area to 2036. It will identify land for new development for the provision of housing, jobs and schools as well as areas for protection. The new Local Plan will also include new policies to help determine planning applications.

The Secretary of State has appointed Yvonne Wright BSc (Hons) DipTP MSc DMS MRTPI as the Inspector. Notice is given of the start of the hearing sessions in accordance with Regulation 24 of the Town and Country Planning (Local Planning) (England) Regulations 2012.

The Inspector has confirmed that the **Independent Examination hearing sessions** will start at 10am on **Tuesday 20th November 2018**. It is envisaged that the hearing sessions will take place on a Tuesday, Wednesday and Thursday extending if necessary to the week beginning 17th December 2018. Further information on the hearing sessions including a programme, agendas and guidance notes will be issued by the Inspector in due course.

The hearing sessions will take place in the Council Chamber, Chelmsford City Council Offices, Civic Centre, Duke Street, Chelmsford CMI IJE. They will commence at 10am unless the Inspector agrees with participants a different start time.
