**6 Statement of intent**

Please explain below why the area is considered appropriate to be designated as a Neighbourhood Area:

East Hanningfield Parish has not been subject to boundary changes within living memory, so, as far as residents are concerned, it is a specific area of long standing. The Parish consists of a rural area with dispersed settlement surrounding a built-up village. The Parish Council has consistently promoted the inclusion of the residents in the dispersed settlement area by producing and delivering a quarterly newsletter to all households in the Parish, thus reinforcing those residents' understanding of their sense of community and their awareness of place from other sources such as their Council Tax bill.

Residents confirm their sense of community by attending Parish Council Meetings when they have a matter of concern. Such attendance is not restricted to those who live in the built-up village area.

In area, the Parish is quite small, so that any development in any part of it will have an impact on its entirety. The residents of the whole parish certainly take an interest in planning matters on the periphery, with large numbers responding to planning applications, such as

the proposed anaerobic digester, which was proposed for a site well away from the village centre, but which attracted comments from more residents than lived close by.

In conclusion, East Hanningfield Parish is a long established, identifiable area which is therefore appropriate for designation as a Neighbourhood Area.

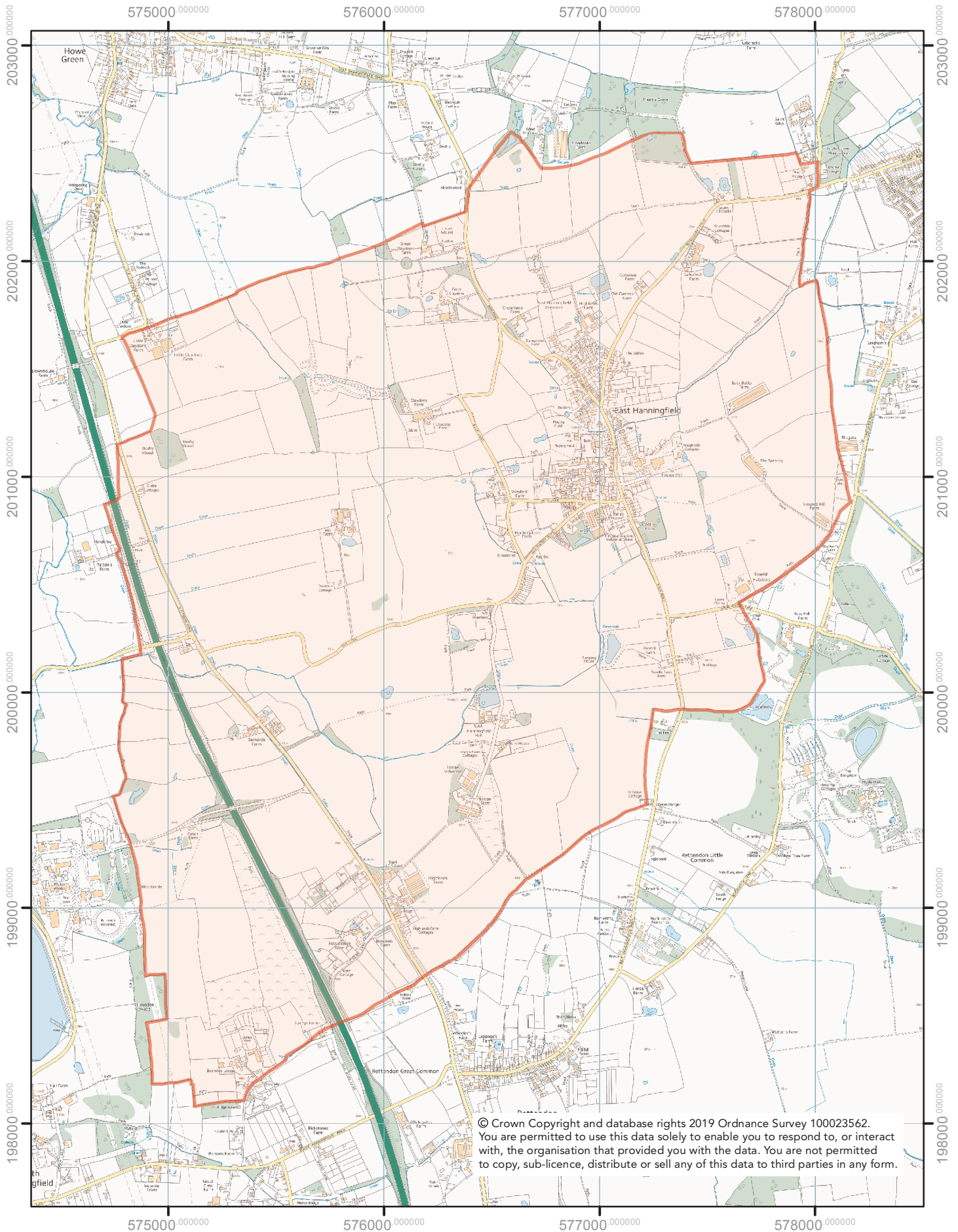
