

Fees for Applications for Permission to Stage a Display of Hypnotism

1. An application fee of £50 is payable in respect of any application for permission to stage a display of hypnotism at premises which are licensed by Chelmsford City Council for the purposes of regulated entertainment.
2. No fee is payable where the premises are: -
 - (i) a Church, hall or similar building occupied in connection with a place of public religious worship; or
 - (ii) a village hall, parish or community hall or other similar building;or where the proposed entertainment is: -
 - (iii) of an educational or other like character, or
 - (iv) given for a charitable or other like purpose.
3. No fee is payable where the display of hypnotism is to be held on premises which are not licensed under the Licensing Act 2003. However, applicants should note that if the proposed entertainment is to incorporate any element of regulated entertainment as defined by the Licensing Act 2003, a Premises Licence may be required. Applicants, who are in any doubt, should seek advice from the Council's Licensing Team or from their own Solicitor.
