How much do you have to pay?

We work out how much Council Tax we must collect by adding together the money each of the four authorities below needs as well as the parish or town council.

This year, the total Council Tax we have to collect is £115,334,360, not including parish and town councils.

If, for example your home is in band D, the average Council Tax for this year will be £1,729.89 plus an amount you have to pay to your local parish or town council (this is shown on your Council Tax bill).
