## DIRECTION NO. 4/1990

### WHEREAS

Authority for the District is satisfied that it is expedient that development of the description set out in the Schedule hereto should not be carried out on the land at Bicknacre Road East Hanningfield and Danbury in the County of Essex as the same is shown coloured red on the plan annexed hereto unless permission therefore is granted on an application made under the Town and Country Planning Act 1990 and the Town and Country Planning General Development Order 1988

NOW THEREFORE the said Council in pursuance of the powers conferred upon it by Article 4 of the Town and Country Planning General Development Order 1988 hereby directs that the permission granted by Article 3 of the said Order shall not apply to development of the description set out in the Schedule hereto on the said land


