
### REGISTER OF MEMBERS' INTERESTS GENERAL NOTICE OF REGISTERABLE INTERESTS


#### SECTION 1 Disclosable Pecuniary Interests (DPI) (Legal duty to provide this under the Localism Act 2011)

1. Members, including co-opted Members, of the Council must include under categories 1 to 7 below:
  - a) their own interests;
  - b) those of their husband or wife, or civil partner; and
  - c) those of any person with whom they are living as if husband and wife or as civil partners.
2. Reference to "you" or "your" in categories 1 to 7 below includes those of anyone referred to in paragraph 1(a) to (c) above.
3. You are only required to include interests that you know about.





<p><b>DPI Category 1:</b> <b>EMPLOYMENT, OFFICE, TRADE, PROFESSION OR VOCATION</b></p> <ul style="list-style-type: none"><li>- Any employment, office, trade, profession or vocation</li><li>- Carried on by you for profit or gain</li></ul>	
<p><b>DPI Category 2:</b> <b>SPONSORSHIP</b></p> <ul style="list-style-type: none"><li>- Any payment or provision of any other financial benefit (other than from your Council)</li><li>- made or provided within the last 12 months</li><li>- in respect of expenses you have incurred:<ol style="list-style-type: none"><li>a. in carrying out your duties as a councillor, or</li><li>b. towards your election expenses.</li></ol></li><li>- This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.</li></ul>	
<p><b>DPI Category 3:</b> <b>CONTRACTS</b></p> <ul style="list-style-type: none"><li>- Any contract made between:<ol style="list-style-type: none"><li>a. you and the Council; or</li><li>b. a body in which you have a beneficial interest and the Council</li></ol></li><li>- under which goods or services are to be provided</li></ul>

<p>or works are to be executed; and</p> <ul style="list-style-type: none"><li>- which has not been fully discharged</li></ul>	
<p><b>DPI Category 4: LAND</b></p> <ul style="list-style-type: none"><li>- Any land in which you have a beneficial interest and</li><li>- that is within the Council's area</li></ul>	Under Section 32(2) of the Localism Act 2011, the Monitoring Officer has decided that your home address need not be disclosed in this category.
<p><b>DPI Category 5: LICENCES</b></p> <ul style="list-style-type: none"><li>- Any land for which you have a licence (either alone or jointly with others)</li><li>- that you are entitled to occupy</li><li>- for a month or longer; and</li><li>- which is within the Council's area</li></ul>	
<p><b>DPI Category 6: CORPORATE TENANCIES</b></p> <ul style="list-style-type: none"><li>- Any tenancy where, to your knowledge,</li><li>- Your Council is the landlord and the tenant is a body in which you have a beneficial interest</li></ul>	





<p><b>DPI Category 7: SECURITIES</b></p> <ul style="list-style-type: none"><li>- The name of any body in which you have a beneficial interest in its securities where:<ol style="list-style-type: none"><li>a) that body, to your knowledge, has a place of business or land in the area of your authority; <b>AND</b></li><li>b) either:<ol style="list-style-type: none"><li>(i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; <b>OR</b></li><li>(ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you have a beneficial interest that exceeds one hundredth of the total issue share capital of that class</li></ol></li></ol></li></ul>

### **SECTION 2** **Other Registrable Interests (ORI)** (Required under the Code of Conduct not by legislation)


1. Members are only obliged to register their own interests under this heading.

<p><b>ORI Category 2: APPOINTMENTS TO OUTSIDE BODIES BY YOUR AUTHORITY</b></p> <ul style="list-style-type: none"><li>- Any body of which you are a member or are in a position of general control or management and to which you are nominated or appointed by your authority</li></ul>	
<p><b>ORI Category 3 OTHER BODIES</b></p> <p>Any body of which you are a member or in a position of general control or management which :</p> <ul style="list-style-type: none"><li>(i) Exercises functions of a public nature</li><li>(ii) Is directed to charitable purposes or</li><li>(iii) One of whose principal purposes includes the influence of public opinion or policy (including any political party or trade union)</li></ul>	
<p><b>GIFTS AND HOSPITALITY</b></p> <p>I have received a gift or hospitality worth £50 or over from the following persons or bodies or other organisations</p> <p>This section only applies to gifts or hospitality received in your capacity as a member of the Council.</p> <p>If you are not sure of the value of the gift or hospitality please estimate it. You should register an accumulation of small gifts or hospitality from the same source over a short period.</p>
