 - (1.41) The Licensing Authority recognises that all applications should be considered on an individual basis and any condition attached to such a licence will be tailored to each individual premises, in order to avoid the imposition of disproportionate and other burdensome conditions on those premises. Standard conditions will therefore be avoided and no condition will be imposed that cannot be shown to be appropriate and proportionate for the promotion of the licensing objectives.

I object to the above application which runs contrary to the city councils stated licencing objectives for...

- the prevention of crime and disorder
- prevention of public nuisance
- public safety

Maltese Road is adjacent to the service station and is the favoured route for pedestrian traffic to the Melbourne area via the footpath to Swiss Avenue. There have been numerous incidents of late night drunken behaviour in Maltese Road and in recent times drug dealing has become commonplace. We fear that providing an additional outlet for alcohol immediately adjacent to the road entrance will only increase the incidents of crime and public nuisance.

There are already plenty of outlets for alcohol, both in the town centre and nearby where purchases can be made until the late evening. Allowing the service station to sell alcohol when all the pubs, night clubs and shops have closed is irresponsible because it will increase the risk of noise and anti-social behaviour in the early hours of the morning. If the license is granted it will therefore increase the potential for public order offences since it will allow those who have already been drinking to continue.

I am writing with reference to the MRH West End Petrol Station Alcohol licencing application and would like to make a representation.

I note that the representation would only be 'relevant' if it relates to the likely effect of the grant of the licence on the promotion of at least one of the four licensing objectives:

- The prevention of crime and disorder
- Public safety
- The prevention of public nuisance
- The protection of children from harm

I am sure that you will be aware that the MRH West End Petrol Station is adjacent to Maltese Road. The neighbourhood watch group and other local residents have raised a number of concerns with the Police regarding anti-social behaviour and other instances of crime occurring in and around Maltese Road. The recent positive and timely response by the Police to these incidents has been reassuring.

I am concerned that granting a 24 hours a day alcohol licence to a local petrol station, which is in close proximity to a residential area, may cause a significant increase in public nuisance and crime in the area. Although Maltese Road is a no through road for motor vehicles it is a regular thoroughfare for pedestrians walking to and from the city centre and there have been instances of anti-social behaviour late at night as people return home after a night out in Chelmsford.

I would argue that granting the alcohol licence to a retailer located a family residential area, such as Maltese Road, will have a likely negative effect on all four of the four licensing objectives and should be refused.

My objection is on the basis that the residents in Maltese Road have experienced problems with anti-social behaviour and do not need the problems exacerbated by individuals purchasing and consuming alcohol in and around our community.

Sadly, puddles of vomit and empty beer cans and spirit bottles are a regular occurrence in Maltese Road. We really do not need to be encouraging even more alcohol consumption when it is already easy to get hold of from supermarkets and small convenience stores. You may not be aware, but half way along Maltese Road there is a cut through to Swiss Avenue and that is a route that is regularly used by individuals intoxicated with alcohol. Why do we need to give them *more* access to it? I ask you to consider my objections and hope that you decide not to grant a licence to the Esso Garage in Rainsford Road.

I live at close to the passageway that leads to Westfield Avenue. I am writing to you regarding the application by MRH West End for 24 hour sale of alcohol.

Alcohol is currently sold during the day and into the late evening by a number of outlets in the area including the Co-op and Tesco supermarkets near the bus station, the Esso garage and corner shops at Maltese Road and Park Avenue. These more than adequately meet the needs of the local communities. These outlets all close down in late evening along with the local public houses in the area. The garage remains open overnight for the sale of petrol and snacks and the majority of its customers will come by car. I do not believe that many of the motorists calling in for petrol during the night are also wanting to purchase alcohol. Therefore this application is aimed at bringing in new customers on foot and it is this that will create the problem in the local roads.

The streets around the petrol station like Primrose Hill, Maltese Road and others off Rainsford Road are all residential and quieten down overnight until people rise again in the morning for work. If you were to open up a licenced premises at the Esso garage overnight it would attract people (late night drinkers) to come to purchase alcohol and to potentially consume it in the residential streets that radiate from the garage. As it would be the only premises selling alcohol in the area it would attract people from the many streets to the south, west and north of the garage. They would mainly come on foot and are likely to consume the alcohol on their way home. People purchasing alcohol at this time of night are unlikely to be purchasing it for a future date. The sale of alcohol at this time of night is inevitably going to lead to drunken behaviour, noise, disturbance and possibly public nuisance.

Maltese Road as you know can be used as a short cut from Swiss Avenue, Corporation Road, Westfield Avenue and North Avenue. Our street is generally a quiet residential road and only on odd occasions at weekends do we hear any noise from people returning home after the pubs have closed. Selling alcohol at the garage overnight could completely change all of that.

The proposal has the potential to create a problem that none of the residents in the streets around the garage want. As you are probably aware the residents of Maltese Road have recently been working with the police to deal with a drug trafficking problem in the locality. The last thing they or the police want is to add a further problem of late night drinking taking place in the vicinity. It thereforeask you to decline this application on the basis that people going to purchase alcohol after the local pubs and shops have closed will consume it shortly afterwards in the streets around the garage. Drinking at this time of night will inevitably lead to raised levels of noise and the possibility of public nuisance.

We object strongly to the application by MRH West End to vary the premises licence for theservice station at 124-134 Rainsford Road, enabling the supply of alcohol for 24 hours daily.

The licensing objectives covering the lodging of representations have been noted, and we are confident – again (see final paragraph) – that this application imperils at least three of them.

- Prevention of crime and disorder: As a link between this and alcohol is undeniable, it must make sense to restrict, rather than increase, the availability of drink a theory to which, we are sure, our overworked police would readily subscribe.
- Public safety: Of all premises where alcohol may be sold, a main road filling station seems to be among the most pointless and least desirable.
- Prevention of public nuisance: Litter bins provided in response to a former residents' campaign are so blithely ignored that Maltese Road has for some time run its own clean-up operation, with neighbours removing cans, bottles, wrappers, cigarette packets and other debris which those who pass through can't be bothered to take with them. Are we expected also to dispose of the additional rubbish which would be the almost inevitable consequence of this application?

Similar objections were put forward, if memory serves, the last time a 24-hour licence was sought here. The application was rejected, and none of the licensing objectives appears to have changed; so why is this up for discussion? Is it to be the pattern for all time – application after application after application, in the hope that the licensing committee will eventually be caught off guard?
