









**REGISTER OF MEMBERS' INTERESTS  
GENERAL NOTICE OF REGISTERABLE INTERESTS**

I, LUKE JAMES GROVES a member of

<p><b>DPI Category 1:</b>  <b>EMPLOYMENT, OFFICE, TRADE, PROFESSION OR VOCATION</b></p> <ul style="list-style-type: none"> <li>- Any employment, office, trade, profession or vocation</li> <li>- Carried on by you for profit or gain</li> </ul>	
<p><b>DPI Category 2:</b>  <b>SPONSORSHIP</b></p> <ul style="list-style-type: none"> <li>- Any payment or provision of any other financial benefit (other than from your Council)</li> <li>- made or provided within the last 12 months</li> <li>- in respect of expenses you have incurred:               <ul style="list-style-type: none"> <li>a. in carrying out your duties as a councillor, or</li> </ul> </li> </ul>	

<p>b. towards your election expenses.</p> <ul style="list-style-type: none"> <li>- This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.</li> </ul>	
<p><b>DPI Category 3: CONTRACTS</b></p> <ul style="list-style-type: none"> <li>- Any contract made between: <ul style="list-style-type: none"> <li>a. you and the Council; or</li> <li>b. a body in which you have a beneficial interest and the Council</li> </ul> </li> <li>- under which goods or services are to be provided or works are to be executed; and</li> <li>- which has not been fully discharged</li> </ul>	
<p><b>DPI Category 4: LAND</b></p> <ul style="list-style-type: none"> <li>- Any land in which you have a beneficial interest and</li> <li>- that is within the Council's area</li> </ul>	<p>Under Section 32(2) of the Localism Act 2011, the Monitoring Officer has decided that your home address need not be disclosed in this category.</p>

<p><b>DPI Category 5: LICENCES</b></p> <ul style="list-style-type: none"> <li>- Any land for which you have a licence (either alone or jointly with others)</li> <li>- that you are entitled to occupy</li> <li>- for a month or longer; and</li> <li>- which is within the Council's area</li> </ul>	
<p><b>DPI Category 6: CORPORATE TENANCIES</b></p> <ul style="list-style-type: none"> <li>- Any tenancy where, to your knowledge,</li> <li>- Your Council is the landlord</li> <li>- and the tenant is a body in which you have a beneficial interest</li> </ul>	
<p><b>DPI Category 7: SECURITIES</b></p> <ul style="list-style-type: none"> <li>- The name of any body</li> <li>- in which you have a beneficial interest in its securities where: <ol style="list-style-type: none"> <li>a) that body, to your knowledge, has a place of business or land in the area of your authority;</li> </ol> <b>AND</b> <ol style="list-style-type: none"> <li>b) either: <ol style="list-style-type: none"> <li>(i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued</li> </ol> </li> </ol> </li> </ul>

## **SECTION 2**

### **Other Pecuniary Interests (OPI)**

- made between you and the Council (or a body in which you or they have a beneficial interest) and

<p style="text-align: center;"><b>NPI Category 1: MEMBERSHIPS</b></p> <p>- Your membership of or the fact that you are in a position of general management and control of a body that falls within one or more of the following descriptions:</p> <ol style="list-style-type: none"> <li>a. to which you have been appointed or nominated by the Council</li> <li>b. exercising functions of a public nature</li> <li>c. directed towards charitable purposes</li> <li>d. one of whose principal purposes includes the influence of public opinion or policy (including any political party or trade union)</li> </ol>	
<p style="text-align: center;"><b>NPI Category 2: GIFTS AND HOSPITALITY</b></p> <p>- Any gift, benefit or hospitality  - with a value in excess of £50,  - which you have accepted as a Councillor from any person or body, other than the Council,  - including the name of the donor.</p>	

I recognise that it may be an offence under the Localism Act 2011 to:-

- (1) omit information that ought to be given in this notice;
- (2) provide information that is materially false or misleading;
- (3) fail to give further notices in order to bring up to date information given in this notice after my re-election or reappointment or to fail to declare a disclosable pecuniary interest that I acquire after the date of this notice and have to declare under the provisions of s. 31 (2) Localism Act 2011.

I also acknowledge that it may be a breach of the Code of Conduct to:-

- (1) omit information that ought to be given in this notice;

(2) provide information that is materially false or misleading;

(3) fail to provide written notification to the authority's monitoring officer of any change in my interests contained in this notice within 28 days of my becoming aware of such change of circumstances
