

APPLICATION FOR INCLUSION ON THE FIT AND PROPER PERSON REGISTER

If applying for more than one manager at one site, (sections K to O) must be completed for each and every relevant or responsible person.

You will need to provide the following documents with the application:

- ✓ Evidence of the applicant's interest in the land (the application must be made by the owner of the land and site licence holder or prospective owner of the land with application for a site licence or transfer of a site licence in progress)
- ✓ Details of the funding arrangements for site management and maintenance
- ✓ A DBS certificate for each relevant person, responsible person or relevant officer dated within 6 months of the date of application
- ✓ Details of the relevant/responsible person(s) experience and competency
- ✓ Details of the management structure for the park and the reporting structure for the named applicant / manager(s) / relevant persons and relevant officers.

NB: supplementary information and evidence may be requested following submission of the application in order to complete the assessment.
