Subject: Urgency Pay Award

Background:

Chelmsford City Council has for a number of years adopted local pay and conditions and consult with regional Unison in this regard.

In April 2022 we locally awarded a 2.5% pay award but undertook to review it in the Autumn once the national pay award was finalised. The national pay award was settled at £1,925 on all pay points and therefore after consultation with regional Unison it was agreed to offer the same to our staff as a replacement to the 2.5%. Staff will therefore receive either £1,925 or 2.5% whichever is higher. Staff currently on grades 2,3 and 4 will also receive an additional day of annual leave.

Whilst recognising the financial situation faced by many local authorities is very challenging this year, our staff are at the very heart of the services we deliver and we want to recognise and reward the work they do at such a difficult time. This also supports recruitment and retention and helps the authority to remain competitive in a very challenging job market.

The Council's 2022/23 budget allowed for a 2.5% increase in pay for all staff. To fund the higher pay award requires approval of an increase to the revenue budget of £1,524,000 in 2022/23, which will be funded from unearmarked reserves. The 2023/24 budget planning will allow for this higher ongoing cost.

Given the cost-of-living crisis and need to maintain staff good will in a difficult financial situation it is imperative to get the back and additional pay to staff in their December 2022 salaries. So, it is appropriate take this decision as an urgency action.

Decision and Reasons for Urgency:

The Chief Executive decided to exercise his delegated authority to take urgent decisions and authorise the increase in the revenue budget. He did so on the grounds that there was an urgent need to pay staff the pay award in their December 2022 salaries.

Supporting Information:

The Mayor, Leader and the Cabinet Member for a Fairer Chelmsford were consulted before taking the decision and had no objection to it.
