Direction restricting Permitted Development on land comprising 10 acres owned by Mr. G. Weal of Ash Tree Stud Little Waltham Chelmsford Essex

Direction No. 2/1990

#### WHEREAS

- The Borough Council of Chelmsford being the Local Planning Authority for the District is satisfied that it is expedient that development of the description set out in the Schedule hereto should not be carried out on an area of land at Ash Tree Stud Little Waltham Chelmsford in the County of Essex as the same is shown coloured red on the plan annexed hereto unless permission therefor is granted on an application made under the Town and Country Planning Act 1971 and the Town and Country Planning General Development Order 1988
- The said Council considers that development of the description set out in the Schedule hereto would constitute a threat to the amenities of its area and that the provisions of Article 5(4) of the said Order should apply to this direction

NOW THEREFORE the said Council in pursuance of the powers conferred upon it by Article 4 of the Town and Country Planning General Development Order 1988 hereby directs that the permission granted by Article 3 of the said Order shall not apply to development of the description set out in the Schedule hereto on the said land

THIS DIRECTION is made pursuant to the provisions of Article 5(4) of the said Order and shall remain in force until 17th December 1990 (being six months from the date of this direction) and shall unless disallowed or approved by the Secretary of State before that date expire on that date
