Policies and Strategies

The report takes into account the South Essex Parking Partnership Document setting out how the SEPP will deal with requests for parking restrictions requiring TROs.

1. Background

The purpose of this proposed Order is to amend The Essex County Council (Chelmsford City) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) Consolidation Order 2019 as set out below:

- 1.1 On 5th March 2021, the SEPP received a completed application form from Cllr Davidson for 'No Waiting at Any Time' restrictions (Double Yellow Lines) on the junction of Trent Road and Thames Avenue, Chelmsford. The request is to prevent obstructive parking and maintain access and visibility on the junction. This application was submitted by Councillor Davidson on behalf of all three ward councillors for St Andrews due to regular complaints they receive regarding parking at this location.
- 1.2 Following receipt of the application the SEPP carried out a number of site visits. During the site visits conducted, vehicles were observed parking on the junction of Trent Road and Thames Avenue particularly during school drop off and pick up times. Rule 243 of the Highway Code states '**DO NOT** stop or park... opposite or within 10 metres (32 feet) of a junction'. Vehicles parking on or near to the junction create problematic and unsafe movement of vehicles as well as access and egress problems.
- 1.3 It has been agreed with the SEPP Joint Committee Member and Lead Officer for Chelmsford to cost a scheme to propose 'No Waiting at Any Time' restrictions on the junction; in line with rule 243 of the Highway Code. The cost of the scheme is estimated at £1500 but will be reduced if incorporated with other roads in Chelmsford to publish one Traffic Regulation Order.
- 1.4 The request was placed before the South Essex Parking Partnership Joint Committee on 13th December 2021 for funding. It was agreed at the meeting to proceed with the necessary Traffic Regulation Order.
- 1.5 The Order was originally published in the Essex Chronicle and on site on 18th August 2022, and copies of the Draft Order were sent to a number of organisations including Essex Police, Essex County Council (the highway authority), Essex Fire & Rescue Service, Essex Ambulance Service, the Road Haulage Association, the Freight Transport Association, and the Chamber of Commerce and Industry.
- 1.6 When the Order was published on 18th August 2022 a 21-day period of formal public consultation commenced.
- 2 Comments
- 2.1 The details of the representations are summarised in Appendix 2 to this report together with the comments of the Technicians.
- 3 Conclusion
- 3.1 Although the correspondents have made a number of points which lead them to believe the Order should not be pursued in whole or part, the SEPP Joint Committee Member, Lead Officer and Technicians consider that none of them are of sufficient weight to warrant the Order not being made.

Comment: By adding yellow lines here, there will be less parking space for those living near this junction. It is almost impossible to park directly outside my home in a 1-car household. Some residents have 3 or 4 vehicles for 1 home. If you proceed with yellow lines, you should also enforce parking permits (1 or 2 free per household, anything additional is chargeable). Driveways are extremely costly and not an option for most. The junction in question poses no issue if driving at the speed of the road and slowing down/being observant. Other options should be considered.

Permit parking is outside the remit of this scheme. Requests suggesting additional restrictions to what has been proposed would require the scheme to be re-advertised. To consider a request for Permit parking our online application form would need to be completed - Request a parking restriction - Chelmsford City Council. However, it should be noted the current cost for a permit in Chelmsford is £26.

Comment: I don't completely disagree with the yellow lines but why don't the Council put some parking in this area for the residents? I live on the corner of Trent and Thames and it is so busy there's often no where to park. When the yellow lines are put in Trent Road it's going to be awful, not sure what Chelmsford City Council are expecting us to do with our cars! You have put the extra parking further down Thames Avenue but not up this end where it is going to be needed.

Requests for additional parking areas should be directed to Essex Highways – the highway authority. The SEPP can only consider on-street parking restrictions.

Comment: and the reasons for my objection are a follows:- The only times there are any issues with parking are during school drop off / pick up, and

occasionally on Sundays when the church holds its services. I do not believe that by imposing these restrictions it will stop the school drop off / pick up traffic. Of course this will be policed in a fashion at the commencement, but it will not deter in the long run. I say this with every confidence, as my daughter attends a school where I have to drive her to and on returning home, there is total disregard for the Highway Code, whether it be zigzags or yellow lines and even residents' premises, as they will use parking bays and, more often than not, literally stop their vehicle in the road, let their child(ren) who may / may not be accompanied by an adult out of the vehicle, and then the driver will most probably stop further down on the zigzags. The school does have a member of staff at the school gate, but nothing is said. My resolution would be for the Council to speak with the school to reinforce 3PR and have ad hoc wardens present. I do not believe that even having a no waiting / parking during the school drop off / pick-up times would even deter many. If this were to go ahead, it will certainly make my school runs difficult as I will no doubt have vehicles parked across my driveway, which already happens, and this in turn makes it nigh on impossible to see vehicles coming up or down the road; I have to pull out blind. In summary, the money allocated for this would be better spent elsewhere, for example, towards removing the island from the previous zebra crossing on Trent Road, as at school times, this is still utilised as a zebra crossing - pedestrians just cross the road to school expecting traffic to stop for them. Another option of an additional zebra crossing between Cherwell Drive and Chignal Road would improve the safety for all. This would stop the school congestion where cars are parked both sides of the road. I think this is much bigger issue than just placing yellow lines.

Restrictions will be enforced as part of a rota as other roads in Chelmsford currently are.

Objection noted.

Comments regarding

enforcement in the area has been noted and passed to our enforcement team.

Lawford Mead Primary and Nursery Scholl is part of a SEPP parking initiative, 3PR. The 3PR School Parking Initiative aims to prevent inconsiderate, illegal and dangerous parking around schools by changing attitudes and behaviours towards parking. The 3PR scheme has been launched at many schools in the six areas that the SEPP covers and has received very positive feedback and has proven to be effective.

If a vehicle is parked across an approved dropped kerb and obstructing the driveway a Civil Enforcement Officer (CEO) can issue a Penalty Charge Notice (PCN) for obstruction of a dropped kerb, provided the vehicle is not parked in a designated parking place. Enforcement of this type will only take place if the resident of the property reports the obstruction to the SEPP. Additionally, a white H bar marking can be placed on the highway indicating the access to the driveway. This type of

marking is advisory only. The SEPP will only offer this option in certain circumstances where a designated bay, such as a resident parking bay, extends across a dropped kerb / driveway and there is an ongoing issue with vehicles obstructing the driveway. In all cases Essex Police is the responsible authority to deal with obstructions of the highway and have the necessary powers to remove vehicles that are considered to cause an obstruction. You should report it to Essex Police online or by calling 101. Queries regarding alterations to the highway or installing traffic calming measures should be directed to Essex Highways the highway authority.
