Chelmsford Local Plan Statement of Common Ground with Anglian Water Services Ltd

- 1. This Statement of Common Ground identifies areas of agreement between Anglian Water Services and Chelmsford City Council in relation to Anglian Water Services representations on the Chelmsford Pre-Submission Sustainability Appraisal (SA), Pre-Submission Habitat Regulations Assessment and Pre-Submission Local Plan.
- 2. This Statement identifies the issues raised by Anglian Water Services in the representations. These are listed in the tables below. The only remaining area of dispute relates to the objection to the inclusion of land in ownership of Anglian Water being included within a Green Wedge. There is also an outstanding suggestion to enhance the Local Plan which continues to be promoted by Anglian Water Services.
- 3. CCC has worked closely with Anglian Water services on the development of the Local Plan, the Sustainability Appraisal (SA) and the Habitat Regulations Assessment (HRA) from the outset. In accordance with the Town and Country Planning (Local Development) (England) Regulations, Anglian Water Services has been formally consulted at every stage of consultation.

Pre-Submission Sustainability Appraisal

4. Anglian Water Services raised no issues with the Pre-Submission Local Plan Sustainability Appraisal (SA) and considers the SA submission document (SD 004) and its accompanying addendum report (SD 005) are comprehensive documents which are supported.

Pre-Submission Habitats Regulations Assessment

5. Anglian Water Services raised no issues with the Pre-Submission Local Plan Habitats Regulations Assessment (HRA) and considers the HRA submission document (SD 006) and its update (SD 007) are comprehensive documents which are supported.

Pre-Submission Local Plan

6. Anglian Water Services support the Pre-Submission Local Plan in its approach to some policies and allocations but also made representations which could enhance the Pre-Submission Local Plan, as well as representations which considered the allocation of a Green Wedge unsound. These are set out in the tables below. Table 1 sets out those areas where Anglian Water Services support the approach in the Local Plan. Table 2 sets out representations made by Anglian Water Services which could enhance the Local Plan which have an agreed way forward with the City Council. Table 3 sets out those comments which have not been taken forward by the City Council but remain as outstanding suggestions for improvement from Anglian Water Services. Table 4 sets out the outstanding objections to the Plan by Anglian Water Services.
