<p style="text-align: center;"><b>DPI Category 7: SECURITIES</b></p> <ul style="list-style-type: none"> <li>- The name of any body</li> <li>- in which you have a beneficial interest in its securities where: <ul style="list-style-type: none"> <li>a) that body, to your knowledge, has a place of business or land in the area of your authority;</li> <li><b>AND</b></li> <li>b) either: <ul style="list-style-type: none"> <li>(i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body;</li> <li><b>OR</b></li> <li>(ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you have a beneficial interest that exceeds one hundredth of the total issue share capital of that class</li> </ul> </li> </ul> </li> </ul>

- with a value in excess of £50,
- which you have accepted as a Councillor from any person or body, other than the Council,
- including the name of the donor.

I recognise that it may be an offence under the Localism Act 2011 to:-

- (1) omit information that ought to be given in this notice;
- (2) provide information that is materially false or misleading;
- (3) fail to give further notices in order to bring up to date information given in this notice after my re-election or reappointment or to fail to declare a disclosable pecuniary interest that I acquire after the date of this notice and have to declare under the provisions of s. 31 (2) Localism Act 2011.

I also acknowledge that it may be a breach of the Code of Conduct to:-

- (1) omit information that ought to be given in this notice;
- (2) provide information that is materially false or misleading;
- (3) fail to provide written notification to the authority's monitoring officer of any change in my interests contained in this notice within 28 days of my becoming aware of such change of circumstances
