### Apologies for Absence

No apologies for absence were received.

### 2. Declaration of Interests

All Members were reminded to declare any interests where appropriate in any items of business on the meeting's agenda. None were made.

### 3. Minutes

The minutes of the hearing held on 25<sup>th</sup> April 2025, were approved as a correct record.

4. Licensing Act 2003 – Application for a New Premises Licence – Sainsbury's, Sainsbury's Supermarkets Ltd, 109 Rainsford Road, Chelmsford, CM1 2PF

The Committee considered an application for a new premises licence made under Section 17 of the Licensing Act 2003 and had regard to the representations made during the consultation period. These related to the promotion of the below Licensing objectives.

- a) The prevention of crime and disorder
- b) Public safety
- c) The prevention of public nuisance
- d) The protection of children from harm

The Committee were informed that the application had sought permission for alcohol sales between the hours of 7am and 11pm, seven days a week as detailed in Appendix B of the agenda item.

It was noted by the Committee that there were three options namely;

- Grant the application, on the terms and conditions applied for.
- Grant the application, on the terms and conditions applied for, modified to such extent as considered appropriate to promote the licensing objectives.
- Refuse the application in whole or in part.

The below parties attended and took part in the hearing:

- Applicants and their legal representative
- Two members of the public

Officers informed the Committee that in response to the application, two representations had been received from local residents.

The applicant's legal representative introduced their client's application to the Committee. They informed the Committee that the application was for a local convenience store which had already been through the necessary planning process. The Committee was informed that they would be looking to hire between 20 and 25 employees, hopefully from the local area. The proposed opening hours were 12am to 12am, seven days a week and they were requesting the alcohol license for the hours of 7am to 11pm, seven days a week. All necessary steps had been taken in relation to crime prevention e.g. CCTV and risk assessments for security personnel. At the time of this hearing, it was not seen as necessary to have security personnel on the premises, but this would be reviewed following reports from staff. The Committee were advised that the Police and other responsible authorities made no representations against the application.

In response to the representations that had been submitted, the Committee heard that concerns were around competition of local businesses, crime, antisocial behaviour and nefarious activities, customer and delivery traffic and safety concerns related to deliveries. In response to this the Committee was informed that no representations were made by the police or responsible authorities for antisocial behaviour. Deliveries would consist of one daily lorry, which will deliver in the early morning before school times to avoid traffic, and an additional smaller vehicle delivery as needed. Entry to the delivery area would be via the car park entrance and would not require the vehicle to reverse in, to minimise the risks. The Committee were advised that some of the areas of concern were already addressed during the planning process and were not relevant to the licensing application.

In response to questions from members of the Committee, the applicant confirmed that they would be happy to look into providing a bin outside the property to manage litter risks, subject to any necessary permissions which may be required. Staff would be parking on the premises car park and members were informed that although there were few parking spaces, it was thought to be adequate for the expected footfall and that other similar premises do not have car parks, additionally the applicant was hopeful that the staff would be local to the area. The Committee was informed that staffing would consist of 2+ staff members, one of which would be a member of the Management Team. Risk assessments would be undertaken and submitted to head office via an internal reporting system and additional security could be used when necessary.

The Committee thanked the attendees and officers for their input and advised that the decision would be made during the deliberation after the meeting. It was noted that due to the remote nature of the meeting, the decision would be circulated to all parties within a few working days via email.

The Committee gave careful consideration to the relevant representations both written and made during the remote hearing.

**RESOLVED** that the Director of Public Places be authorised to grant the application on the terms applied for.

### A. Reasons for decision

- (1) In reaching its decision the Committee gave careful consideration to the application and the relevant representations both written and made in the course of the remote hearing. The Committee also had regard to the current statutory guidance issued under section 182 and Chelmsford City Council's licensing policy.
- (2) All decisions on licensing applications must be evidence based.
- (3) The Committee had given due weight to the fact that there were no objections to the application from any of the Responsible Authorities, whether on the grounds of crime and disorder, public nuisance, public safety or otherwise. In particular, the Committee was bound to give weight to the fact that Essex Police had not objected to the application, nor had they sought to have any conditions attached to the granting of the licence. The section 182 guidance stated that Licensing Authorities should look to the police as their main source of advice on crime and disorder (para 2.1).
- (4) Furthermore, some of the objections submitted included matters or concerns (including but not limited to; the effect of having another off-licence outlet in the locality and traffic) which were not relevant because they did not relate to any of the four licensing objectives. The Committee could not therefore, take these matters into account and was expressly required to disregard them by virtue of regulation 19 of The Licensing Act 2003 (Hearings) Regulations.
- (5) At this point in time there was no evidence before the Committee on which it could properly conclude that, if the licence were to be granted, the licensing objectives would be undermined.

#### **B.** Informatives

#### 1. Litter

(1) Whilst not a condition of the approval, the Committee would ask that the applicant make suitable attempts to maintain cleanliness in the surrounding area and consider providing a suitable bin for waste disposal. This will help ensure the space remains tidy and respectful for all users and nearby residents.

### Purpose

The purpose of this report is for members to consider a Premises Licence Application given by Piratheepan Thavarasa, made under section 17 of the licensing act 2003, for the grant of a premise licence in respect of 212 Watchouse Road, Galleywood, Chelmsford, CM2 8NF having regard to representations received and the requirement to promote the four licensing objectives. These are:

- a) The prevention of crime and disorder
- b) Public Safety
- c) The prevention of public nuisance
- d) The protection of children from harm

### Recommendations

Members are advised that they have the following options when determining this application.

Grant the application, on the terms and conditions applied for

- Grant the application on the terms and conditions applied for, modified to such extent as considered appropriate to promote the licensing objectives.
- Refuse the application in whole or in part.

An appeal in respect of any determination made in connection with this application may be made to the Magistrates Court, within 21 days of the notification given by the licensing committee, by the licence holder, Chief officer of police, or any other person making relevant representation.

### 1. Background and Introduction

1.1 The premises is located along Watchouse Road which joins Pipers Tye and has residential properties either side and behind. A map of the area is provided at **Appendix A** for reference.

### 2. Application

- 2.1 The application has been properly given in accordance with The Licensing Act 2003 and all procedures correctly followed. The completed application form is attached as **Appendix B**.
- 2.2 The application form for the premises licence was received on the 6<sup>th</sup> May 2025, and correctly advertised by placing blue public notices at the premises, by publication in a local paper and on Chelmsford City Council's website.
- 2.3 The new premises licence application provides for the licensable activity which is the sale of alcohol, between 06:00 to 23:00 Mondays to Saturdays, and 07:00 to 22:00 on Sundays. Plans have also been submitted and are attached as **Appendix C.**
- 2.4 Mr Thavarasa is the proposed designated premises supervisor having obtained a personal licence from Thurrock Council.
- 2.5 Members are asked to note that as this report is available in the public domain, personal details have been redacted from some documents. However, both the Authority and the applicant have received complete copies of all documents.

### 3. Representations

- 3.1 During the course of the application, Chelmsford City Council, in line with the Act, sent a copy of the application to all responsible authorities.
- 3.2 During the consultation period, twenty-two (22) representations were received, all objecting to the application, one rep was from a City Cllr, one from a responsible authority (Essex fire) and the remaining ones are from members of the public. A copy of these objections is attached as **Appendix D**.

3.3 Conditions were agreed with Essex Police, a copy of these are attached as **Appendix E.** 

### 4. Conclusion

- 4.1 Members are reminded that Section 13 of the Council's Statement of Licensing Policy relates to the procedures and responsibilities of the Licensing Committee. This includes the structure of sub-committees, the criteria for decision-making, the application of conditions, and the delegation of functions to officers.
  - Section 13 does not raise any procedural or policy issues that would affect the determination of this application.
- 4.2 This application has been correctly submitted and processed in line with the requirements of the Licensing Act 2003.
- 4.3 At the conclusion of this hearing, members are advised to consider the options set out in the recommendations section at the beginning of this report.

### **Corporate Implications**





NOTES ON DEMONSTRATING ENTITLEMENT TO WORK IN THE UK

# Entitlement to work/immigration status for individual applicants and applications from partnerships which are not limited liability partnerships:

A licence may not be held by an individual or an individual in a partnership who is resident in the UK who:

- does not have the right to live and work in the UK; or
- is subject to a condition preventing him or her from doing work relating to the carrying on of a licensable activity.

Any premises licence issued in respect of an application made on or after 6 April 2017 will become invalid if the holder ceases to be entitled to work in the UK.

Applicants must demonstrate that they have an entitlement to work in the UK and are not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity. They do this in one of two ways: 1) by providing with this application copies or scanned copies of the documents listed below (which do not need to be certified), or 2) by providing their 'share code' to enable the licensing authority to carry out a check using the Home Office online right to work checking service (see below).

#### Documents which demonstrate entitlement to work in the UK

- An expired or current passport showing the holder, or a person named in the passport as the child of the holder, is A British citizen or a citizen of the UK and Colonies having the right of abode in the UK [please see note below about which sections of the passport to copy].
- An expired or current passport or national identity card showing the holder, or a person named in the passport as the child of the holder, is a national of a European Economic Area country or Switzerland.
- A Registration Certificate or document certifying permanent residence issued by the Home Office to a national of a European Economic Area country or Switzerland.
- A Permanent Residence Card issued by the Home Office to the family member of a national of a European Economic Area country or Switzerland.
- A **current** Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder indicating that the person named is allowed to stay indefinitely in the UK, or has no time limit on their stay in the UK.
- A **current** passport endorsed to show that the holder is exempt from immigration control, is allowed to stay indefinitely in the UK, has the right of abode in the UK, or has no time limit on their stay in the UK.



The community does not need an off license, This is going to cause issues with parking, noise, anti social behaviour and members of the public lingering in a fully residential area. This is going to cause issues with parking, noise, anti-social behaviour and members of the public lingering in a fully residential area. I completely oppose this licensing application, hours they have applied for the licensing and the hours of opening.

I am writing to raise a formal and strong objection to the premises licence application submitted by Mr. Piratheepan Thavarasa for 212 Watchouse Road, Galleywood, Chelmsford. The application proposes the conversion of the premises into an off-licence,

with the sale of alcohol permitted from 06:00 to 23:00 Monday to Saturday, and from 07:00 to 22:00 on Sundays.

This application is wholly inappropriate, both in terms of location and proposed operating hours. It poses significant risks to public safety, community wellbeing, and the residential character of the area. My specific concerns are as follows:

### 1. Wholly Inappropriate Location

212 Watchouse Road is situated at the quieter end of Watchouse Road in Galleywood, a small, rural village. While there is a parade of shops approximately 0.5 miles up the road, the immediate area surrounding 212 is predominantly residential, with no other businesses in close proximity. The property is directly opposite a field where horses are kept, which is emblematic of the area's peaceful, countryside nature. This location is fundamentally unsuitable for an off-licence, particularly one with extended hours. It is entirely out of character with its surroundings.

### 2. Excessive and Irresponsible Proposed Hours

The hours proposed in this application are, quite frankly, unreasonable and unjustifiable. The request to begin selling alcohol from 6:00 AM, seven days a week, is especially troubling. There is no justification for alcohol sales at this time of day in any residential area - let alone in a quiet village setting.

Early morning alcohol sales invite the risk of inappropriate loitering and potential antisocial behaviour during hours when families and children are starting their day. The proposed operating hours are excessive, show a clear disregard for the needs and expectations of local residents, and significantly increase the risk of disruption, noise, and public nuisance.

### 3. Proximity to Children and School Routes

A significant number of children pass this premises daily on their way to and from school. The presence of an off-licence in such close proximity raises serious concerns about their exposure to individuals purchasing or consuming alcohol, particularly during the morning and afternoon hours. This not only poses safeguarding risks but also undermines the safe, family-oriented environment that Galleywood residents hold dear. Additionally, the early morning and late-night hours proposed for alcohol sales increase the likelihood of alcohol consumption before or after driving, putting children and pedestrians at further risk from potential drunk drivers in the area. This is an unacceptable threat to the safety of the community.

### 4. Existing Local Issues and Unnecessary Duplication

The local area is already well-served by multiple established businesses selling alcohol, including Tesco Express, Morrisons, and the Co-op, all of which are situated in appropriate commercial zones. Additionally, the White Bear Pub, located on the same road opposite Morrisons, already provides alcohol sales within walking distance. The presence of these outlets, coupled with the proposed off-licence, makes it clear that there is no need for another alcohol provider in this location.

Moreover, the Co-op on Barnard Road, despite being situated in a commercial area, already experiences ongoing antisocial behaviour and frequent police attendance. Introducing an offlicence in a more isolated and residential setting is likely to replicate, if not worsen, these issues - without the necessary infrastructure or oversight to contain them. The community is

already adequately served, and the addition of another alcohol-selling outlet would only increase the potential for disturbances, noise, and other negative impacts on the surrounding area.

5. Negative Impact on Residential Amenity

The introduction of an off-licence in this setting will inevitably lead to an increase in noise, litter, disruption, traffic, parking issues, and the potential for antisocial conduct. The rural and residential character of Galleywood is a key reason why many residents live here. This application would compromise that character and set an unacceptable precedent for future development.

### Conclusion

This application is wholly inappropriate in terms of location, timing, and community impact. The proposed hours are excessive and out of step with the quiet nature of the area. The operation of an off-licence at the end of a residential lane, opposite grazing land, and along a major school route is not only ill-conceived but risks significant and lasting harm to the safety, tranquillity, and wellbeing of the community.

I therefore urge Chelmsford City Council to reject this application in its entirety.

#### Hello

I would like to object to the application for the following premises to receive a licence to operate as an Off Licence:

Application for 212 Watchouse Road, CM2 8NF to operate as an Off Licence

### Public Safety

- 1. The entrance is immediately adjacent to a difficult road junction that is already subject to an unusually high volume of minor accidents.
- a. The entrance is adjacent to the Pipers Tye triangle. Hundreds of cars, plus commercial traffic including articulated lorries from Parklands Farm & Rignals Lane Industrial Estate come through this difficult junction.
- b. A large number of these vehicles choose, or have no option but to drive up immediately next to the driveway entrance to 212 Watchouse Road
- some of these vehicles have to look backwards at a difficult angle to see if it is safe to join traffic on Watchouse Road travelling in a West direction (a frequent bus route)
- equally some vehicles wish to turn back on themselves to drive towards Great Baddow (the majority of cars & vans prefer to drive up to 212 Watchouse Rd, as they find that driving the narrow part of the Pipers Tye triangle is more dangerous & difficult to see safely when to join Watchouse Road travelling to Great Baddow).
- c. Attempts to reduce the speed of traffic entering Galleywood from Great Baddow have not had much success & a high number of vehicles approach 212 Watchouse Road well above the 30mph limit

(an advisory indicator of vehicle speeds near 212 Watchouse Road has not been effective & is not functioning)

the reduction of the speed limit between Great Baddow & Galleywood to 40mph has unfortunately not reduced the speed of many vehicles who seem to find the rural route with numerous bends to be a challenge.

- 2. The children walking to Great Baddow Secondary School (& others walking to Baddow etc) walk along an increasingly narrow path past this difficult junction opposite 212 Watchouse Road.
- 3. The volume of traffic using the existing premises (car spare parts, with less people able & willing to work on their cars) has been very low & decreasing in recent years while the general level of traffic has been increasing. A significant increase in traffic for another retail premises that is open from early morning until very late at night will cause an increase in problems with this junction within 1 metre of the entrance to 212 Watchouse Road.

The prevention of crime and disorder

This part of Galleywood is a quiet area adjacent to the pleasant grass triangle of Pipers Tye, which incorporates the village book exchange (a converted red telephone box). We believe the addition of an off licence in this area will attract people to congregate on the green area (a spot with more than normal accidents) & this may lead to inevitable temptation to cause damage to the young trees planted & the book exchange, which so far have not attracted idle youths etc.

The protection of children harm

As stated above the children walking the narrow path opposite the already difficult junction.

The likely gathering of youths drinking in this quiet area may create a problem area due to the nature of the area.

The prevention of public nuisance

The proposal for early morning opening & very late closing 7 days a week will be a significant nuisance for the properties in this part of Galleywood & specifically near to the premises:

- a. due to the problems of increased traffic with the adjacent difficult junction
- b. with vehicle doors closing & noise of visitors (pedestrian & from vehicles).

Although the existing retail premises has low traffic volumes & is open at much less than the proposal on the application, there are a number of existing visitors that do not bother to pull into the driveway, but park their vehicles on Watchouse Road, or partially on the road & path (an extremely busy bus route & through route for vast numbers of residents in Great Baddow, Sandon, Danbury & all areas east of Galleywood). This may be because they have missed the entrance, or just because they prefer for other reasons to pull up on the road (such as lazy, or not getting caught getting back out amongst the traffic).

My main concerns are as follows:

### 1. Public Safety & Nuisance

The proposed opening hours (up to 11pm Monday–Saturday and 10pm Sunday) are significantly later than most nearby shops, which generally close by 10pm. This extended schedule may attract late-night gatherings and result in increased foot and vehicle traffic to a quiet, residential part of Galleywood.

### 2. Lack of Suitable Access and Parking

There is no street parking available. Access to the shop is only via the driveway, which can accommodate a maximum of four vehicles at a time. Cars reversing to exit the property could pose risks to pedestrians and nearby residents. Deliveries will further complicate access and increase disruption.

### 3. Proximity to Schools & Sale to Minors

The property sits directly on a key route to Great Baddow High School. I have personal concerns, as with many similar off-licences, about the irresponsible sale of alcohol and vape products to underage individuals.

### 4. Impact on Local Residents

The proposed premises directly adjoin residential homes, including families with young children whose bedrooms face the shop entrance. Late-night customers pulling in at 10:45pm will undoubtedly disturb residents' peace and quiet.

### 5. Environmental Impact

There are no provisions for waste disposal or rubbish bins, which may lead to littering. The area is currently peaceful and home to local wildlife, including horses, birds, and squirrels — an environment that should be preserved.

Granting this licence would undermine the safety, peace, and character of the community. I urge you to consider these concerns seriously in relation to the four licensing objectives under the Licensing Act 2003.

I feel that this would cause Anti -social behaviour and Would cause a problem of drinking in public around pipers tye green which is a focal point of the parish and having a building that could sell alcohol for 17 hours a day every day of the week will encourage this sort of behaviour. Please bear in mind that pipers tye/ watchouse rd and surrounding areas are a residential area with lots of children that live around the green.

The Parking and arrival/ departure of this premises is a another major concern as this particular part of watchouse rd / piper tye green already is prone to car accidents and with the number of schools nearby the children that walk past there and cross there daily it would be a hazard for them and public safety especially with the lack of lighting in the area late a night it will just matter of time that there would be a accident.

There is already issues in the area where police are called out regularly to drunk and disorderly behaviour around the other shops in the area that sell alcohol and I don't want this to happen outside my house where young children live.

Plus with the re hab centre that is now in stock, we are already seeing the individuals going through re hab up at the local shops where they get prescription from the pharmacy for their meds, and once they find this off licence and most likely end up drinking on the green where I fear for the local children's safety will be at risk of being around this type of shop and people it will draw to it.

I am writing to formally object to the application of an Off Licence at 212 Watchouse Road CM2 8NF.

I have significant concerns regarding the potential impact this application will have on my quality of life and the surrounding neighbours/community.

Specifically, I object on the following grounds -

#### **Public Nuisance**

I am concerned that the increased foot traffic and activity will lead to a rise in noise, litter and general nuisance particularly in the evenings in our quiet and peaceful road.

There will be an influx of vehicles pulling up late into the evenings with car doors slamming, engines running and muffled car radio, and with the quietness of the road this noise will be amplified. There are vehicles pulling up throughout the day at the current shop which doesn't concern me as it is within reasonable hours.

### **Public Safety**

The location of these premises is near a junction which has already seen a number of accidents. Additionally, there will be even more vehicles crossing the pavement to enter the shop front, thus putting passing pedestrians including school children at risk.

#### Crime and Disorder

The presence of an Off Licence is likely to increase crime and disorder in the area. Increased alcohol consumption can contribute to incidents of vandalism, theft and public intoxication, creating a less safe environment for residents especially those that are vulnerable. There is a village green opposite these premises, I fear this may be an area where young people may congregate with alcohol especially on summer evenings, causing anti social behaviour, disturbances and an increase in litter.

#### The Protection of Children of harm

The potential for increased alcohol availability near a residential area can negatively impact the safety and well being of children. These premises are on a route taken by many high school students on their way to and from school.

Children are easy influenced and more vulnerable to the dangers of alcohol and this increased availability could contribute to underage drinking and associated harmful behaviours.

### **Appendix D**

There are already two premises in the village where alcohol can be purchased, there isn't a need for a further one. The long opening hours are completely unacceptable and show no consideration to neighbouring properties.

The presence of an Off Licence bang in the middle of a pretty village green will ruin the character, charm and peacefulness of the area.

I am writing to express my concerns about the application for an off licence on watchhouse Road as I do not think an establishment of this kind with long opening hours is needed or appropriate for the location which is a quiet village with predominantly families and elderly residents. There are a number of other shops Morrisons. Co op and Tescos) local to the area that sells alcohol.

My objections are on the basis of the prevention or crime and disorder. My concern is that a shop selling alcohol late at night will attract people from out of the village and having consumed alcohol are likely to cause disruptive and criminal activity and being a small residential village there is no police presence and little street lighting at night.

I am concerned that this will have an impact on public safety. The area is largely populated with families and there are children living either side of the property with many more children that walk past on the way to school both primary and secondary. My concern is that children will have greater exposure to alcohol and the behaviour of those under the influence of alcohol and given that many of the teenagers walk around in groups there will be a greater risk and encouragement of underage drinking.

The late-night sale of alcohol will create an environment that

normalizes alcohol consumption amongst

the many children in the area potentially leading to future alcohol-related problems.

With the potential increase in people driving to the property this also poses an additional road safety risk. There have already been a number of accidents on the road outside the property and this is likely to worsen with additional traffic and as already stated this is a route where children cross the road walking to school. The bend from pipers tye to watchouse road is sharp and with additional traffic there will inevitably be more incidents. There will be a likelihood of congestion that will not only be a nuisance to the direct neighbours but may prevent the flow of the traffic around the village.

I am also objecting on the basis of public nuisance. The additional vehicle and pedestrian traffic will cause additional noise late at night and early in the morning, this will disrupt my children's sleep as our bedrooms overlook the property. This will also create light pollution late at night as there is little street lighting.

The green opposite could then become an area for people hanging out drinking, getting drunk, urinating, arguing and littering the green which is the focal point of the village.

For these reasons I strongly urge the planning committee to reject the application.

I am writing to formally object to the planning and licence application for the proposed offlicence at 212 Watchouse rd, Galleywood, CM2 8NF.

My objection is based on concerns directly relating to the four licensing objectives set out in the Licensing Act 2003:

### 1. The Prevention of Crime and Disorder

There is significant concern that granting a licence to sell alcohol at this location will contribute to an increase in anti-social behaviour, petty crime, and public drinking. The proposed off-licence is situated in a quiet, predominantly residential suburb characterised by family homes, retirement properties, and a close-knit community atmosphere. The area is home to many elderly residents, young families with children, and individuals who value the peaceful and safe environment that defines the neighbourhood. Streets are generally calm, and there is a strong sense of neighbourliness and mutual respect. The presence of schools, parks, and community centres nearby further highlights the area's suitability as a family-oriented and retirement-friendly location. Introducing an off-licence here would fundamentally alter the character of the area, potentially attracting antisocial behaviour, late-night disturbances, and loitering, which would be wholly inappropriate and detrimental to the wellbeing of residents.

### 2. Public Safety

An off-licence in this location poses a risk to public safety. The premises is close to a busy road and public transport links, which may encourage on-street drinking and gatherings that could increase the likelihood of accidents or confrontations, particularly during high footfall times. Increased footfall from individuals seeking alcohol may also affect the feeling of safety for local residents, especially the elderly and vulnerable.

### 3. The Prevention of Public Nuisance

### **Appendix D**

Late-night alcohol sales can lead to noise disturbances, littering (e.g., bottles, cans, packaging), and general disruption for nearby residents. The presence of an off-licence may attract individuals who congregate in the area, causing ongoing nuisance particularly in the evenings and at weekends. Such disturbances would negatively impact the quality of life for those living nearby.

#### 4. The Protection of Children from Harm

The proposed premises is situated close to schools, parks, and residential areas frequented by families and children. The increased availability of alcohol, particularly if sold at discounted prices, may encourage underage drinking or make alcohol more accessible to minors through proxy purchasing. This raises serious concerns about the safeguarding of children and young people in the local area.

In light of the above concerns, I strongly urge the Licensing Authority to refuse this application in order to uphold the licensing objectives and maintain the safety and wellbeing of the local community.

As stated above it is situated in a very large residential area of Galleywood, with no other shops around.

Most of the properties are semi detached but there are also detached properties close by together some very old properties built over one hundred years ago with province.

Opposite the site is the old village pump with the parish council endeavouring to keep this area an open aspect for that end of the village....having secured the old red telephone box as well.

The site is some half a mile from a Co-op shop in Barnard Road, where alcohol can be purchased, and about three quarters of a mile away in the centre of Galleywood is the village shops, where alcohol may be purchased in the small supermarket and post office.

In the other direction about half a mile away towards Great Baddow you have another supermarket in Dorset Avenue selling alcohol, together with the main shops of Great Baddow where several shops sell alcohol.

Whilst we must not be looked upon as opposing residents who drink alcohol, there is no need to need to make it so easy for alcohol to be obtained. A Licensed shop selling alcohol in the middle of a large residential area where there are five or more shops within close proximity – another shop selling alchol is not necessary!!!

Whilst the area may be easy for motorists to drive up onto the shop driveway, it is the slamming of car doors, talking, shouting late at night especially for the right hand side detached property ajoining the Galleywood Motor Spares shop. You can see from the times set out below – this license is for double the hours – especially night time - that this Motor Spares shop is open at present.

some of whom may be unable to contact you directly. There are significant concerns regarding this application, and I wish to raise the following objections.

### 1. Prevention of crime and disorder:

The establishment of a licensed premises in this residential area could lead to various forms of anti-social behaviour. This would necessitate additional police resources, which is particularly challenging given the current constraints on police budgets.

Please note: Nearby is a City Council-owned Park and Pipers Tye which also includes the village sign and pump, a traditional red telephone box now serving as a library, post box and the recently planted Mayors' tree. These features could be at risk of vandalism from visitors who may become attracted to the area to purchase alcohol and consume close to the premises, potentially leading to disruptive behaviour such as noise, intoxication, and disorderliness.

### 2. Public safety:

If this application is approved, the area may experience an increase in vehicular activity. While the premises do have parking available at the front (what was originally the semi-detached properties driveway), it is likely that users may need to reverse onto the main road. The close proximity of the junction with Pipers Tye should be taken into consideration. Although this method of operation is currently in place, the proposed extended opening hours will inevitably increase the frequency of such occurrences, thereby increasing the associated risks. It is important to note that children and elderly individuals often cross the road at this location, and there is a 30-mph vehicle-activated sign nearby, indicating that traffic speed is a concern in this area.

### 3. Prevention of public nuisance:

212 Watchouse Road is surrounded by residential properties. The premises itself forms part of a semi-detached house.

The small family-run car spares shop has shorter opening hours and does not stay open late as proposed in the licence application.

Current Car Spares Shop 9am - 5pm Monday to Saturday and 10am to 1pm on Sundays.

Proposed New Shop Opening & Licensed Hours 6am – 11pm Monday - Saturday and 7am – 10pm on Sundays.

The nearby Co-Op and Morrisons Daily are open 7 days a week and Great Baddow also have licensed premises. Both close at 10pm, but if this application to sell alcohol until 11pm is approved, it could cause noise and nuisance for the surrounding properties. Specifically, the adjoining property may experience increased disturbance from people coming and going, car doors slamming, car radios, and additional light pollution from car headlights, shop lighting and potentially any new signage that could require lighting in the future.

### 4. Protection of children from harm:

With the proposed new longer opening hours, children in neighbouring properties will face additional noise, potentially affecting their health, wellbeing, and education due to disrupted sleep. Settling children to sleep can already be challenging, and this situation would exacerbate it regularly.

### **Appendix D**

Considering this is a residential area, the increased traffic movements as previously mentioned significantly alter the current peaceful and safe living environment, potentially exposing children and other residents to harmful situations or conditions.

Given the reasons provided, I do not see a valid requirement for granting a new licence to the premises, as it will clearly lead to additional issues hence my objection.

I object to the application for a licence for the sale of alcohol for 212 Watchouse Road, Galleywood for the following reasons:

- 1. The premises are situated in a quiet, residential area, with family houses on all sides, and adjacent to a sizeable green area maintained by the Parish Council containing the village book exchange and a historic pump. Although the premises are presently in use as an auto spares shop, this is only open between 9.00am and 5.00pm on Mondays to Saturdays, closed on Sundays. An increase in opening hours as proposed in the application to Monday to Saturdays 6.00 am to 11.00 pm and Sundays from 7am to 10pm will cause substantial harm to the families in the surrounding area because of increased pedestrian and vehicle traffic, especially during evening hours when children are sleeping.
- 2. The village of Galleywood is well served with shops selling alcohol at the village centre and the Co-op on Barnard Road, all within walking distance of these premises. I am concerned that the proposed premises will attract trade from outside the area, and that this will increase anti-social behaviour in an otherwise very quiet, semi-rural area.

3. Although there is parking space outside the premises, there is a serious risk to road safety, whether or not customer numbers increase. Cars drive into the space in front of the premises forward, but have to reverse out, onto the main road between Galleywood and Great Baddow at a very nasty bend, with a risk of serious accidents.

### 212 Watchouse Road - proposed conditions.

- 1 The premises shall have installed and maintain a closed circuit television surveillance (CCTV) system which at all times complies with the below requirements:
  - i. CCTV will be provided in the form of a recordable system, capable of providing pictures of evidential quality {in all lighting conditions} particularly facial recognition;
  - ii. CCTV cameras shall cover all entrances {and exits} and the areas where alcohol sales take place;
  - iii. Equipment must be maintained in good working order, be correctly time and date stamped, recordings must be kept in good working order and kept for a minimum period of {31} days;

Upon the reasonable request of the police or licensing authority staff, within 48 hours viewable copies of recordings will be provided

- 2 Signs must be displayed at all entrances {and exits} advising customers that CCTV is operating at the premises and shall be a minimum size of 200 x 148 mm and clearly legible at all times when the premises conducts licensable activities
- 3 Other than wine or spirits, no alcohol with an alcohol by volume content above 6.5% will be sold or offered for sale.
- 4 A Challenge 25 scheme shall be operated, whereby any person who appears to be under the age of 25 years of age is required to produce on request an item which meets the mandatory age verification requirement **and** is either a:
  - Biometric Home Office photo ID
  - European National ID Card
  - Ministry of Defence Form 90 (Defence Identity Card)
  - Passport (UK or International)
  - Photo Driving Licence (UK or European)
  - Proof of Age Standards Scheme (PASS) card

Where Home Office approved (not yet approved) digital proof of identity assurance technology is in use, this condition applies only when confirming that a person is 18 years or older following a failure of that technology to do so.

5 - The premises shall clearly display signs at the each point of sale and in areas where alcohol is displayed advising customers that a 'Challenge 25' policy is in force.

At the point of sale, such signs shall be a minimum size of 200mm x 148mm

6 - A refusals record shall be maintained at the premises that details all refusals to sell alcohol. Each entry shall, as a minimum, record the date and time of the refusal and the name of the staff member refusing the sale.

All entries must be made as soon as possible and in any event within 4 hours of the refusal and the record must be made immediately available to police, trading standards or licensing authority staff upon reasonable request.

The refusals record shall be either electronic or maintained in a bound document and retained for at least {12} months from the date of the last entry.
